Seoul: Rally against Japanese plans to release N-wastewater

SEOUL: Anxious about Japan's impending release of treated nuclear wastewater from the tsunami-damaged Fukushima nuclear power plant, hundreds of South Koreans marched in their capital on Saturday. Protesters called for Tokyo to abandon the plans, and expressed anger

toward Seoul for endorsing the discharge despite alleged food safety risks. Saturday's rally was the latest of weeklong protests since the International Atomic Energy Agency approved the Japanese discharge plans in July.



In deadly Maui wildfires, communication failed

Chaos overtook Lahaina along with the flames

In the hours before a wildfire engulfed the town of Lahaina, Maui County officials failed to activate sirens that would have warned the entire population of the approaching flames and instead relied on a series of sometimes confusing social media posts that reached a much smaller audience. Power and cellular outages for residents further stymied communication efforts.



Radio reports were scarce, some survivors reported, even as the blaze began to consume the town. Road blocks then forced fleeing drivers onto one narrow downtown street, creating a bottleneck that was quickly surrounded by flames on all sides. At least 67 people have been confirmed dead so far.

Hector Bermudez left his apartment at Lahaina Shores after 4:30 pm on Tuesday after the smell of smoke woke him up from a nap.

He asked his neighbour if he was also leaving. "He said, 'No, I am waiting for the authorities to see what they are going to do,'" Bermudez recounted. "And I said, 'No, no, please go. This smoke is going to kill us. You have to go. Please. You gotta get out of here. Don't wait for nobody.'" His neighbour, who is about 70 and has difficulty walking, refused.

The silent sirens have raised questions about whether everything was done to alert the public in a state that possesses an elaborate emergency warning system for a variety of dangers including wars, volcanoes, hurricanes and wildfires.

Oprah Winfrey seen helping residents

Part-time Maui resident Oprah Winfrey on Thursday gave her time and support to wildfire evacuees at a makeshift shelter as devastating flames continued to rage on the once-idyllic island. The media mogul, 69, was spotted handing out supplies and speaking with residents at the War Memorial Stadium in Wailuku, which has been converted into a shelter and resource center, Hawaii News Now reported, according to nypost.com. The former talk show host, who has lived on the island part-time for at least 15 years, offered to bring supplies — including cots, blankets, and toiletries, the relief group Kakoo-Haleakala told the news outlet. In a video shared by the group, Winfrey, wearing a straw hat, is seen organising what appears to be blankets and pillows.



Maui's Emergency Management Agency did not immediately respond on Friday to questions about sirens and other communications issues. Hawaii's Attorney General Anne Lopez said her office will be conducting a comprehensive review of decision-making and standing policies surrounding the wildfires.

"My Department is committed to understanding the decisions that were made before and during the wildfires and to sharing with the public the results of this review," she said in a statement on Friday.

Officials told to provide med facilities to Imran Khan

The Islamabad High Court (IHC) on Saturday directed the Attock Jail administration to provide former prime minister Imran Khan with "appropriate medical facilities" and allow him to meet

his friends and family according to law. "He (the former prime minister) may also be provided with the prayer mat and English version of the Holy Quran," the court said. Pakistan Tehreek-e-Insaf (PTI) chief Khan was on August 5 declared guilty

by a trial court here of "corrupt practices" in the Toshakhana case for concealing details of state gifts. He was sentenced to three years in prison and was soon arrested and taken to the Attock Jail in Punjab province. The trial court had ordered

the Islamabad police chief to arrest Khan but he was instead arrested by the Lahore police.

The court had ordered the Adiala Jail superintendent to receive Khan but the former premier was taken to the Attock Jail.

हमला कर अस्पताल में छोड़ा, मौत के बाद परिचित पर केस दर्ज

इंदौर। 48 वर्षीय कमला बाई की मौत हत्या में बदल गई। खुड्डेल थाना पुलिस ने उसके परिचित वीरु उर्फ आनंद राव के खिलाफ हत्या का केस दर्ज किया है। आनंद ही महिला को एलाय अस्पताल लेकर गया था। उसने फर्जी नाम से महिला को मर्ती करवाया था। एस्पपी (गामीपी) सुनील मेहता के मुताबिक, शिवदरिन नगर (मुसाखेड़ी) निवासी कमला बाई तेजाजी नगर क्षेत्र में ढाबा चलाती थीं। 21 जून को शाम करीब 5 बजे उसका परिचित वीरु उर्फ आनंद राव निवासी आलोक नगर अजाद नगर उसे फ्लेट दिखाने के बहाने आते दिखने से निलगिरी परिसर दुर्गिया (खुड्डेल) ले गया था। आरोपित ने विवाद हुआ और वीरु ने कमला बाई के सिर पर चार चोटें लगाईं। कमला बाई के घरे के बाहर चलाकर अस्पताल लेकर गया और उसने स्वयं का नाम संतोष बताया। गुमराह करने के लिए वीरु ने कमला के बेटे राकेश उर्फ मुकेश को भी कॉल लगाकर बताया कि कमला अस्पताल में मर्ती है। एस्पपी के मुताबिक, पीएम रिपोर्ट और राकेश के कथनों के आधार पर हत्या का केस दर्ज किया गया है।

पथराव कर रहे बदमाशों ने पुलिसवालों पर किया हमला

इंदौर। वकील के घर पथराव कर रहे बदमाशों ने पुलिसवालों पर भी हमला कर दिया। पुलिस ने शासकीय कार्य में बाधा पहुंचाने के आरोप में केस दर्ज किया है। घटना तिलक नगर थाना क्षेत्र स्थित गोवाल नगर की है। आरोपित आकाश एलिस और उसका साथी वकील कृष्णाकांत मितल के घर पथराव कर रहे थे। मितल ने डायल 100 पर फोन कर पुलिस बुलाई तो आरोपित विवाद करने लगे। मौके पर पहुंचे जवान तेजेंद्र और सुरेंद्र से भी उलझ गया।

इंदौर। दूसरी पत्नी को पहली पत्नी के बारे में पूछना गरीब पड़ गया और वह पति की मारपीट का शिकार हो गई। लखडिया पुलिस को किरण सोनी ने शिकायत दर्ज करवाई कि जब उसने अपने पति शुभम तोमर से पहली शादी और पत्नी के बारे में पूछा तो शुभम ने सतुष्टिपूर्वक जवाब नहीं दिया और मारपीट करने लगा। फरियादिया ने पुलिस को बताया कि लखडिया से ही शुभम उसके साथ अमर व्यवहार कर रहा था और समुदाय वालों से भी शुभम ने दहेज के नाम पर 2 लाख 20 हजार रु नगदी लिए थे जिसके बाद मकान खरीदने के लिए रखा की मांग करने लगा। पुलिस ने मामला दर्ज कर जांच शुरू कर दी है।

इंदौर। मुस्लिम बहुल इलाकों में लगे पोस्टर से खुफिया तंत्र चौकस है। रातोंरात लगे इन पोस्टर की किसी को भनक तक नहीं लगने दी गई। पोस्टर पर आपत्तिजनक बातें तो नहीं मिली, फिर भी यह पता नहीं चला कि पोस्टर आपत्तिजनक करने वाले कौन हैं। इसके पूर्व पंढरीनाथ, बंबई बाजार, रावजी बाजार क्षेत्र में इसी प्रकार के पर्चे बांटे जा चुके हैं। मौलाना शादाब द्वारा आपत्तिजनक भाषण देने की घटना से खुफिया तंत्र ज्यादा सक्रिय है। इस बार पोस्टर सदर बाजार, जूना रिसाला, जिंसी क्षेत्र में लगे हैं। इन पर लिखा कि हजमारी शहजदियों के कदम बहकाए जा रहे हैं। उनके जेहन को फेरा जा रहा है। उनके दिलों-दिमाग को बरगलाया जा रहा है। इस खराबी को रोके लू खुफिया एजेंसी ने इस घटना को गंभीरता से लिया है। अफसरों का मानना है पोस्टर लव जिहाद का विरोध करने के कारण लगाए गए हैं। कुछ समय पूर्व भी इसी तरह से मुस्लिम इलाकों में खुला खत बांटा गया था। उसमें हिंदू संगठन, बजरंग दल और आरएसएस के विरुद्ध आपत्तिजनक भाषा का प्रयोग किया था।

महिला से हरकत दो युवतियों से भी छेड़छाड़

टैंकर में बच गई थी गैस बताया जाता है कि टैंकर में कुछ गैस बच गई होगी। टैंकर को गैस कट्टर से काटते समय उसमें धमाका हो गया। अनहोनी की आशंका में क्षेत्र में भगदड़ मच गई। भंवरकुआं थाना पुलिस मौके पर पहुंची और जांच शुरू की।

युवती को अश्लील वीडियो भेज दी धमकी, गिरफ्तार

इंदौर। लव जिहाद मामले में तुकोगंज पुलिस ने जिशान उर्फ शादाब के साथी हमजा को भी गिरफ्तार किया है। हमजा एक कॉल सेंटर में नौकरी करता है। उसने पीड़िता की बहन को अश्लील वीडियो भेज धमकाया था कि जिशान से बात न करने पर वह उसे बदनाम कर देगा। तुकोगंज टीआई जितेंद्र यादव के मुताबिक, क्षेत्र में रहने वाली 19 वर्षीय युवती को आरोपित जिशान ब्लैकमेल कर रहा था। पंचम की फैल में रहने वाली युवती अर्पोलो टावर में नौकरी करती थी। आरोपित ने नाम बदलकर दोस्ती की और मतांतरण के लिए दबाव बनाने लगा। आरोपित ने भाई की हत्या की धमकी दी और युवती के साथ अश्लील वीडियो बना लिया। युवती ने परेशान होकर जिशान से बातचीत बंद की तो उसने वीडियो हमजा को भेज दिया हमजा ने पीड़िता की बहन को वीडियो भेजा और कहा कि तू अपनी बहन से बोल कि जिशान से बात कर ले। वरना उसका वीडियो लोगों के पास पहुंचा देगा। परेशान होकर पीड़िता ने आत्महत्या की कोशिश भी की।

जेल भेज दिया। शनिवार को पुलिस ने पीड़िता के कोर्ट के समक्ष कथन भी दर्ज करवा दिए। पीड़िता ने कहा कि मैं एक साल पूर्व अर्पोलो टावर में काम करती थी। जिशान से इसी दौरान परिचय हुआ था। उसने कहा कि शादी करेगा। तुम मुस्लिम बन जाओ। युवती ने परेशान होकर बातचीत बंद कर दी। वह 56 दुकान के पास काम करने लगी। वह लगातार कॉल करती थी। भाई की हत्या की धमकी दी और कहा कि उसे रास्ते से हटा देगा। वह एक लाख रुपये भी मांग रहा था।

गाड़ी के लिए दोस्त बन गया दगाबाज
